However, upon the occurrence of a WESCO change of control involving the issuance of additional shares of WESCO common stock or other WESCO change of control transaction, in each case, approved by holders of WESCO common stock, a holder of these shares will have the right, subject to certain limited exceptions, to convert some or all of these shares on the change of control conversion date into a number of shares of WESCO common stock pursuant to a conversion formula.
