**Explanation of Responses:**

- The Reporting Person received a grant of 1,817 restricted stock units (RSUs) under the Issuer's long-term incentive plan. Each RSU represents a contingent right to acquire one share of Issuer's common stock. The RSUs vest in three equal installments beginning on the first anniversary of the date of grant.
- The Reporting Person has reported prior awards of RSUs in Table II of Form 4. The total reported in Column 5 includes 1,817 newly awarded RSUs, 12,860 previously reported RSUs and 17,596 shares of common stock.
- Represents shares acquired upon settlement of performance share awards granted on February 13, 2020 under the Issuer's long-term incentive plan. Each performance share award represented a contingent right to receive one share of the Issuer's common stock if the Company achieved specified performance goals during the three-year period ended December 31, 2022.
- Represents tax withholding on the settlement of performance share awards granted on February 13, 2020.
- Represents tax withholding on the vesting of RSUs that were granted February 17, 2022.
- The stock options become exercisable in three equal annual installments beginning on the first anniversary of the date of grant.
